Effective January 1 2017, the government is introducing an 8% Rebate on electricity bills. If eligible, this rebate will reduce your electricity bill by 8%, an amount equal to the provincial portion of the HST, for electricity used on and after January 1, 2017. If your account qualifies for the 8% Provincial Rebate, please complete this form and return to our office by email, fax or mail as soon as possible.

**Step One – Does your account qualify?**

Your account qualifies if your property falls into one of the following categories:

1. a dwelling,
2. a property, within the meaning of the Condominium Act, 1998,
3. a residential complex, within the meaning of the Residential Tenancies Act, 2006, without regard to Section 5 of that Act, or
4. a property that includes one or more housing units and that is owned or leased by a co-operative, within the meaning of the Co-operative Corporations Act.
