

SELF-DECLARATION FORM 8% Rebate on Electricity Bill

Residential customers, small businesses, farm customers and others who are considered low-volume users of electricity (designated consumers) are eligible to receive an 8% rebate on their electricity bill effective January 1, 2017, under the Ontario Rebate for Electricity Consumers Act, 2016. While accounts that purchase their electricity through the Regulated Price Place (“RPP”) are automatically eligible, accounts that pay the spot price for electricity are required to complete a Self-Declaration Form in order to receive the 8% rebate. This includes farming businesses and multi-unit residential premises. If you are not already receiving the 8% rebate and your account meets any of the eligibility criteria below, please complete, sign and date this form, and return it to us by email, fax or mail as soon as possible.

If you qualify for the rebate, Orillia Power will retroactively credit your account (as applicable) for consumption since January 1, 2017 or to a maximum of two years from the date you provide us with the completed Self-Declaration Form, if submitted after January 1, 2019.

Step One – Does your account qualify?

Your account qualifies if your property falls into one of the following categories:

1. a dwelling,
2. a property, within the meaning of the Condominium Act, 1998,
3. a residential complex, within the meaning of the Residential Tenancies Act, 2006, without regard to Section 5 of that Act, or
4. a property that includes one or more housing units and that is owned or leased by a co-operative, within the meaning of the Co-operative Corporations Act.

Non-traditional Residential Complexes

I acknowledge that all information submitted in this process may be used by Orillia Power in support of its obligations under the Ontario Rebate for Electricity Consumers Act, 2016, the Electricity Act, 1998, the Ontario Energy Board Act, 1998, applicable Ontario Energy Board Codes and Rules, associated policies, standards and procedures and its electricity license. I give consent to Orillia Power to use the information collected on this form for the purposes of confirming my eligibility for the 8% rebate, applying the 8% rebate to my electricity bill and for auditing purposes as applicable.

The following individual has the authority to provide and certify the accuracy of the information on this form and any additional attachments. It is an offence to make a false or deceptive statement in a document submitted under the Ontario Rebate for Electricity Consumers Act, 2016. Any penalty resulting from falsifying this Self-Declaration Form shall be borne by the account holder.

Orillia Power will apply the 8% Rebate to your account(s) upon receipt of a completed Self-Declaration Form and review of eligibility. The accounts will reflect the 8% Rebate until such time that you advise us in writing that the account no longer qualifies for the 8% Rebate, or if there are changes to the 8% Rebate causing your account(s) to no longer qualify.

Orillia Power will use the information collected on this form for the purposes of confirming your eligibility as an eligible multi-unit residential complex for the 8% rebate. This information is being collected and used for billing and auditing purposes and will remain confidential in accordance with Orillia Power's privacy policy.
